#### Planning for Age Friendly Communities and Regions:

Valerie Spain, Age-Friendly Lead of AARP Massachusetts presented on concepts and examples of age-friendly planning. Her presentation and example plans and other resources were distributed with these meeting notes.

#### MAGIC FY 2018 Work Plan and Special Assessment:

The group discussed the elements of the work plan, and decided to add to the work plan that in FY 2018 MAGIC will host a forum on Age-Friendly Community planning, and discuss interests in a





regional project related to the topic. (Update June 1, 2017). MAGIC representatives voted unanimously in favor of adopting the work plan with the proposed addition.

The group also discussed the requests for Special Assessment allocations to the **Climate Change Mitigation and Adaptation: Coordination & Implementation** and **Regional IT Services and Support Office.** MAGIC representatives voted unanimously in favor of allocating \$5,000 and \$10,000 respectively to each project. An estimated \$10,200 remain in the Special Assessment.

**Community Exchange:** Marc Draisen, MAPC's Executive Director joined MAGIC during the community exchange to provide information about MAPC's work related to MAGIC interests, and hear from representatives about their work and field questions. He commented on MAPC's work and interest in supporting communities related to: Age-friendly community planning; stormwater management; and converting to LED streetlights (for more on LED Streetlight initiatives: proche@mapc.org).
