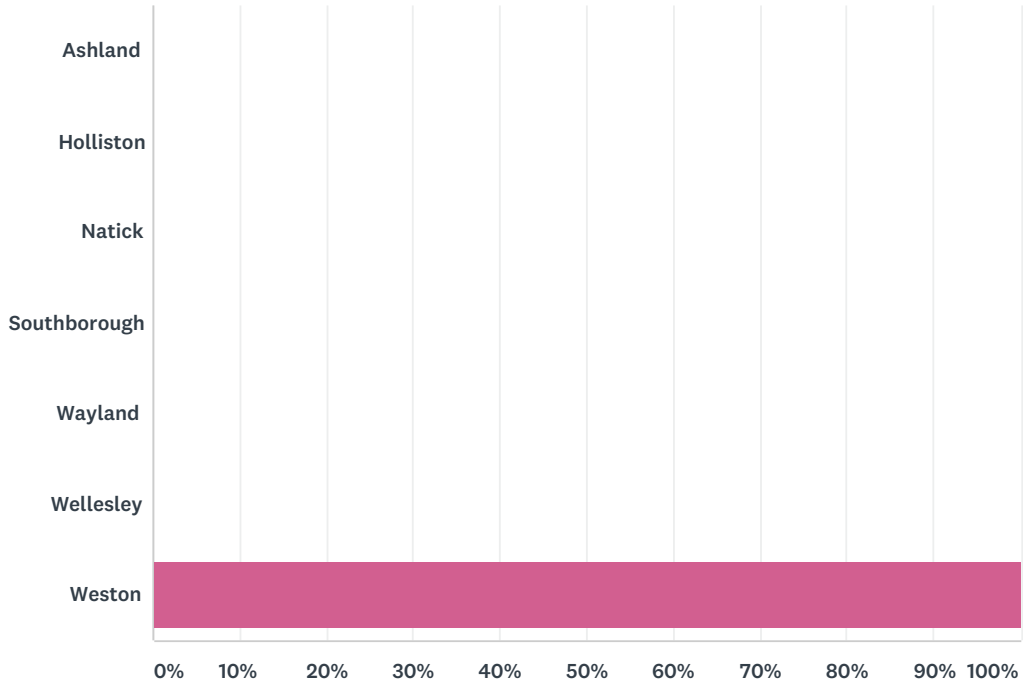

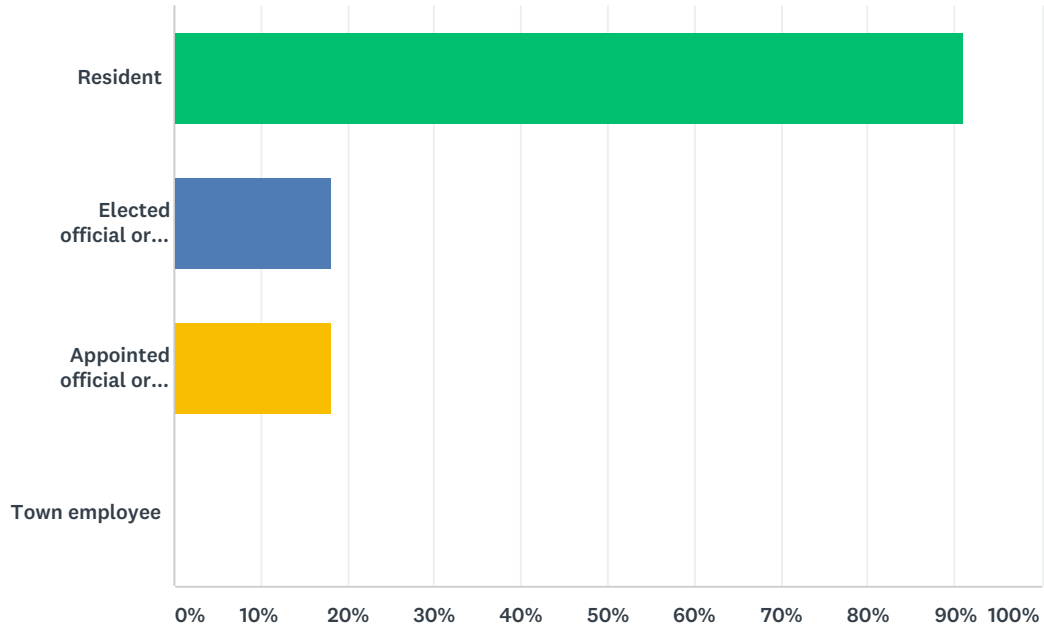

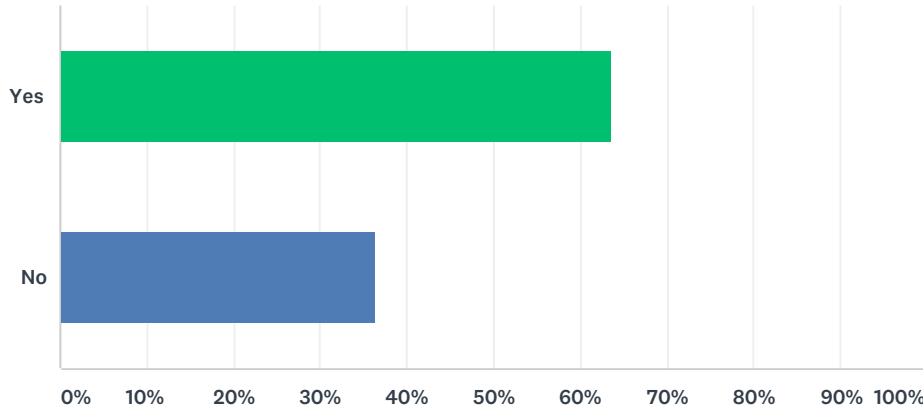

### Q3 Do you think Town Meeting is an effective form of government?

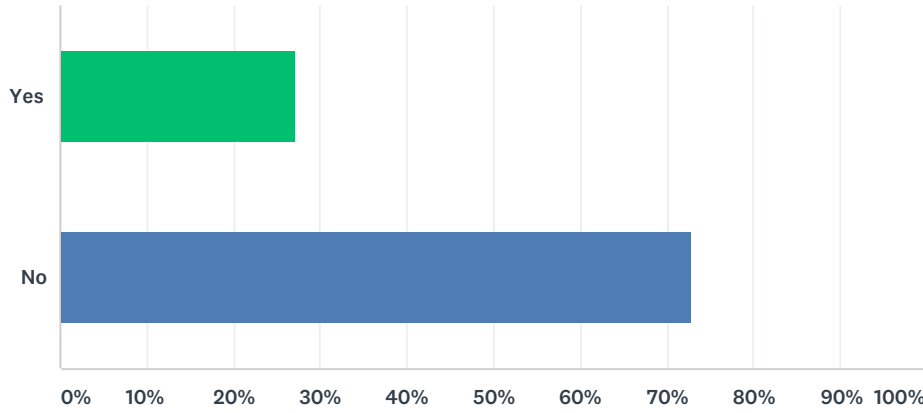

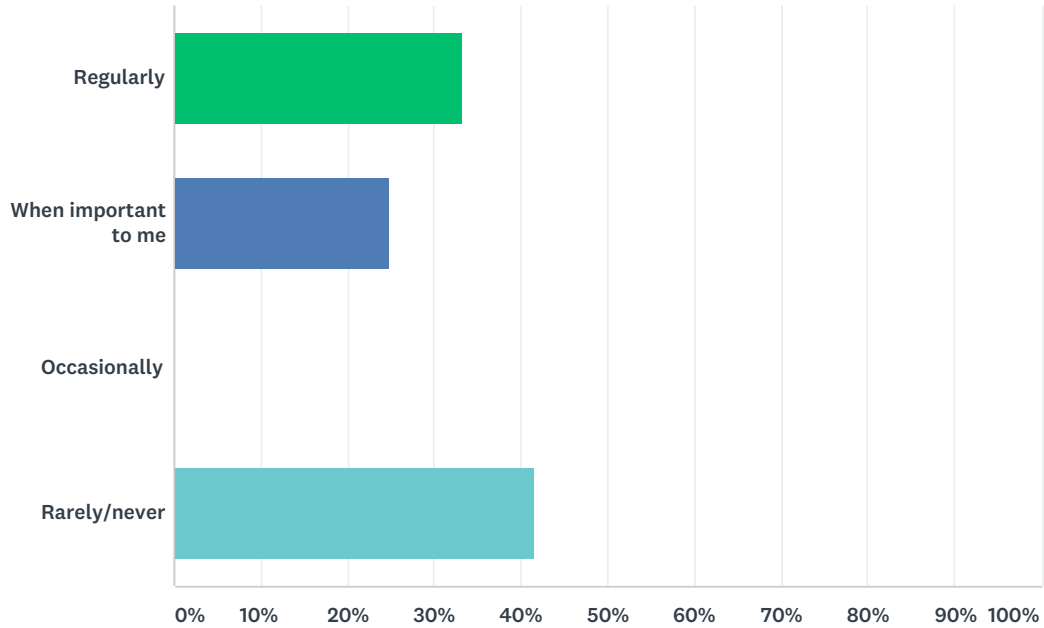

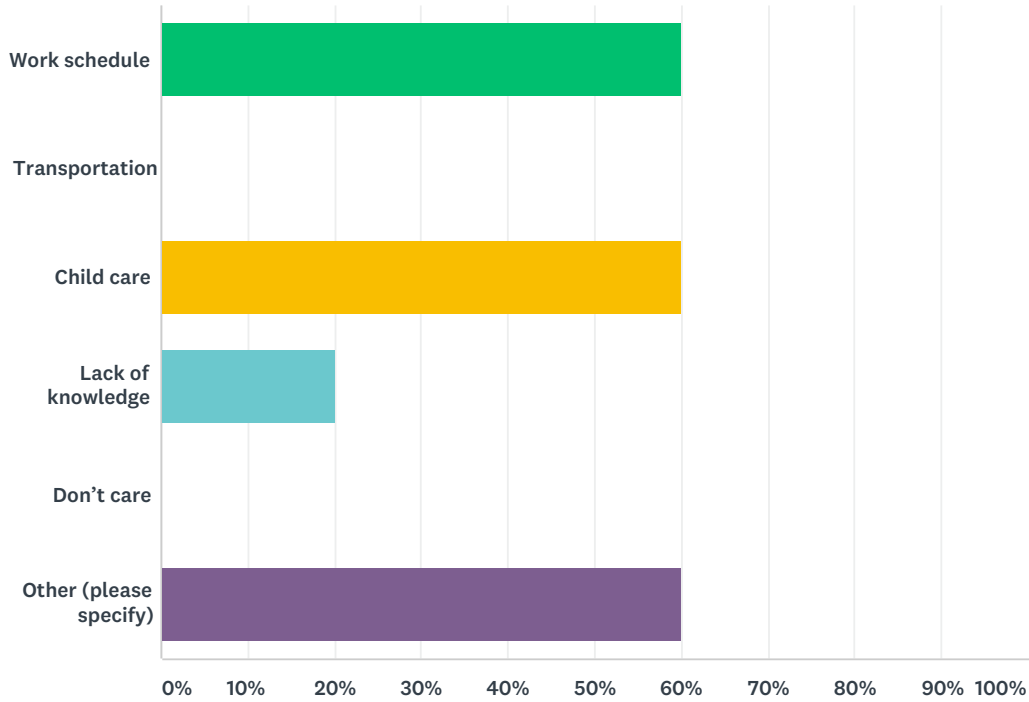

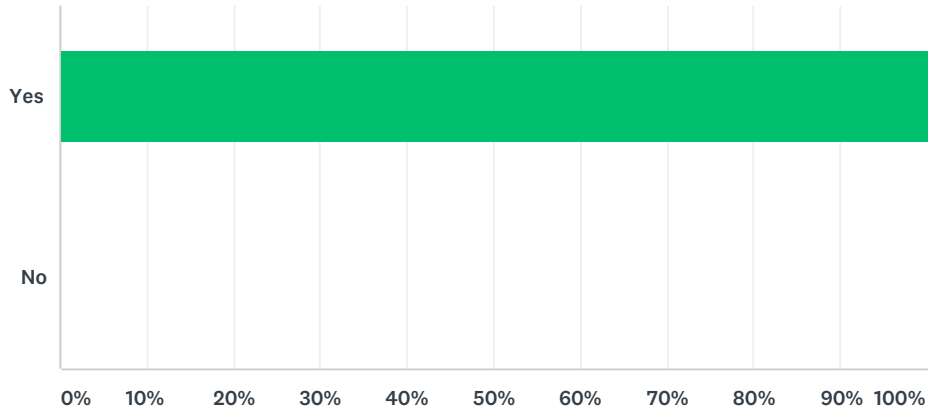

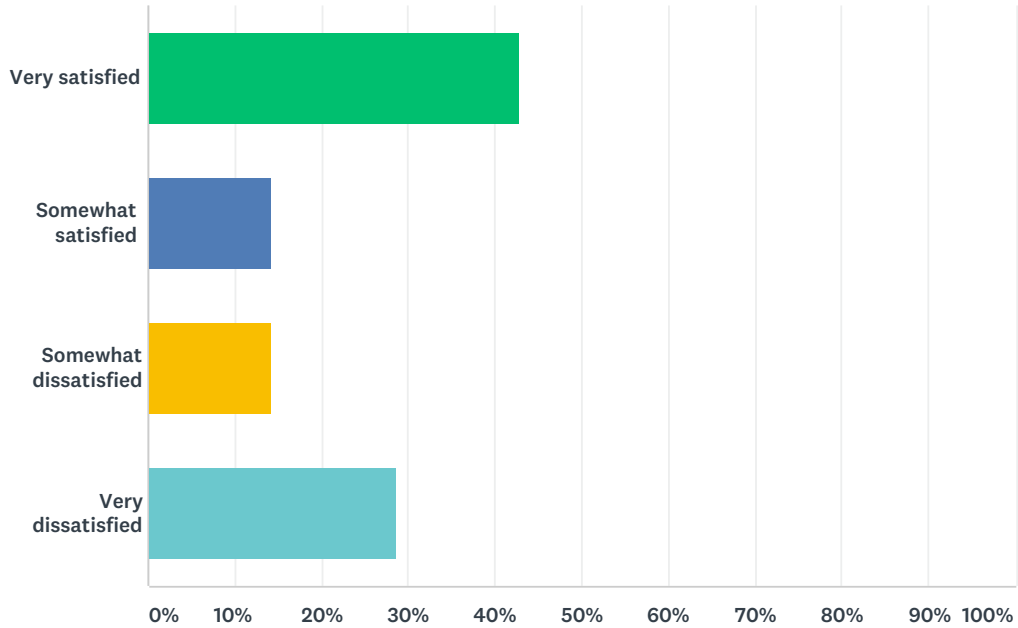

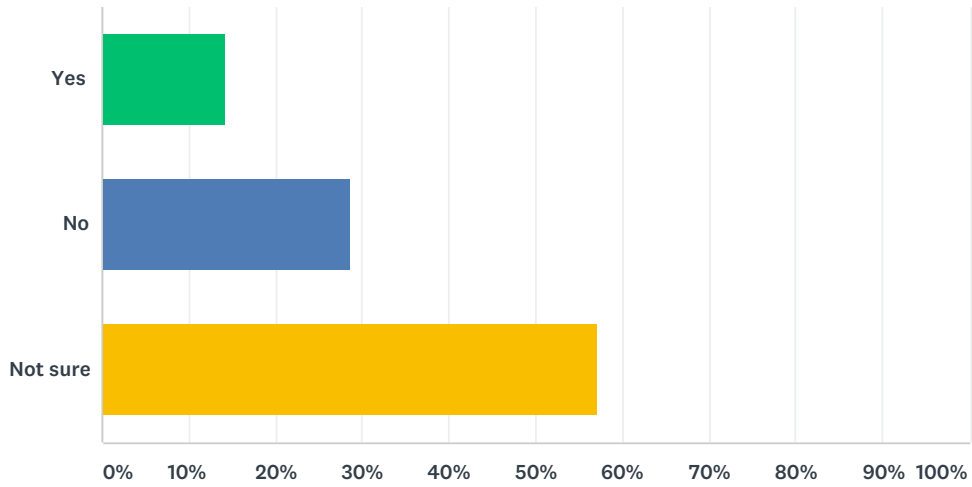

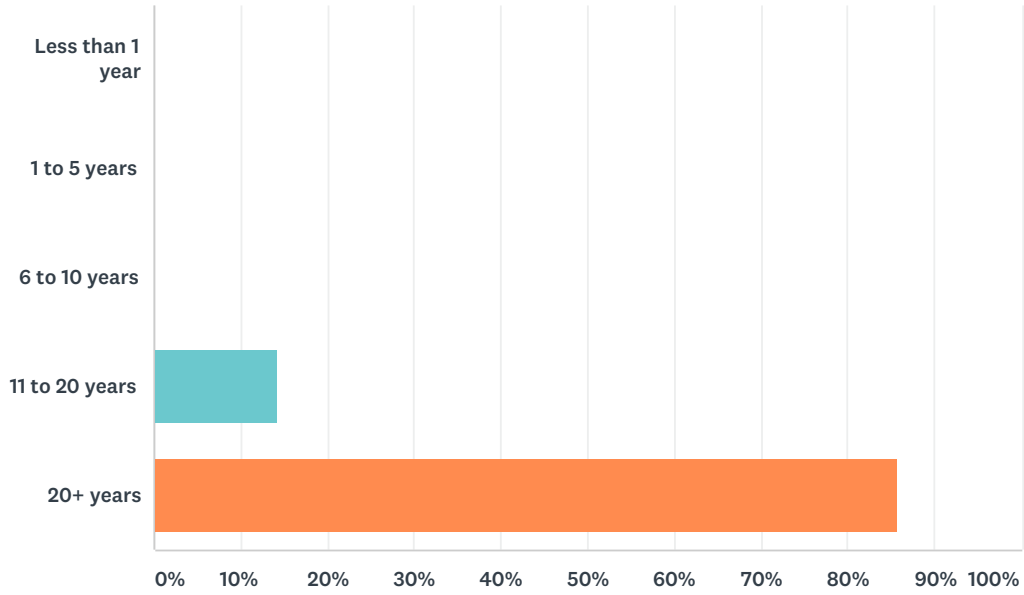

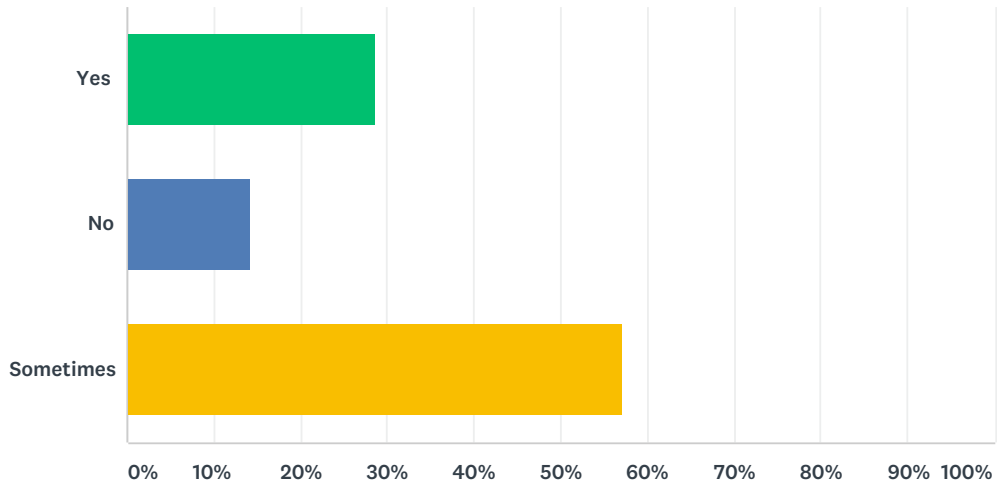

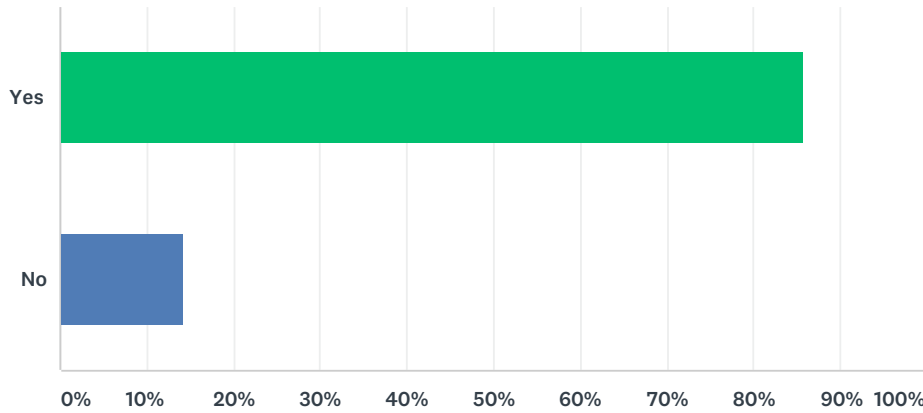

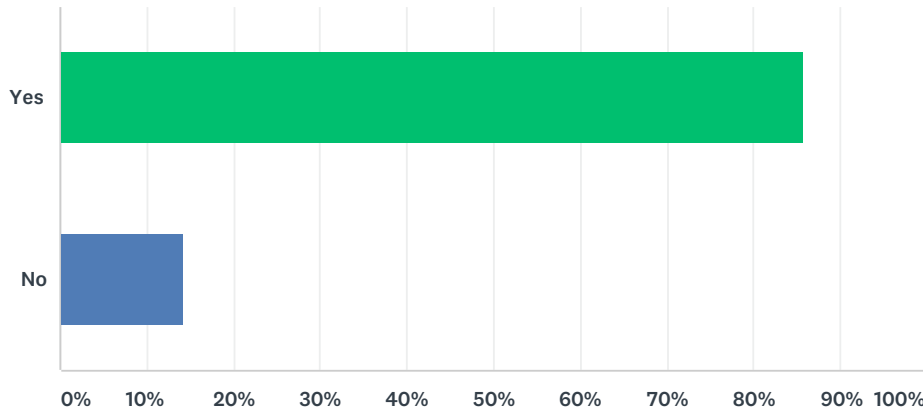

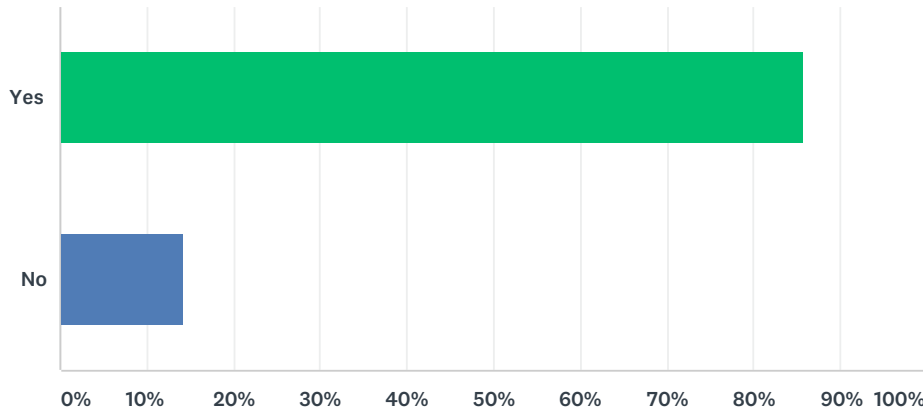

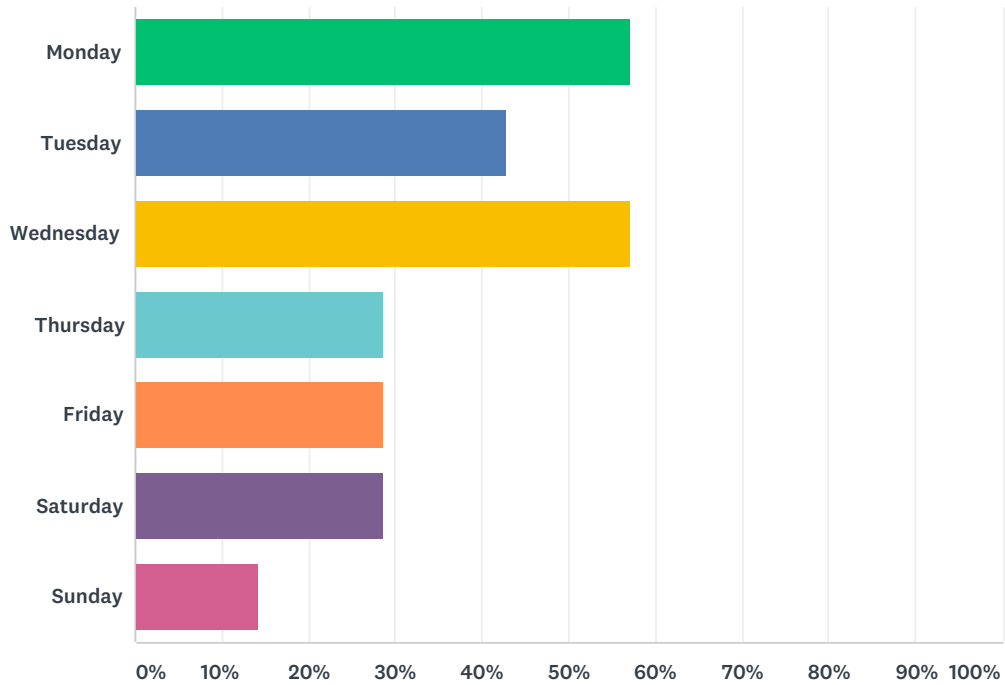

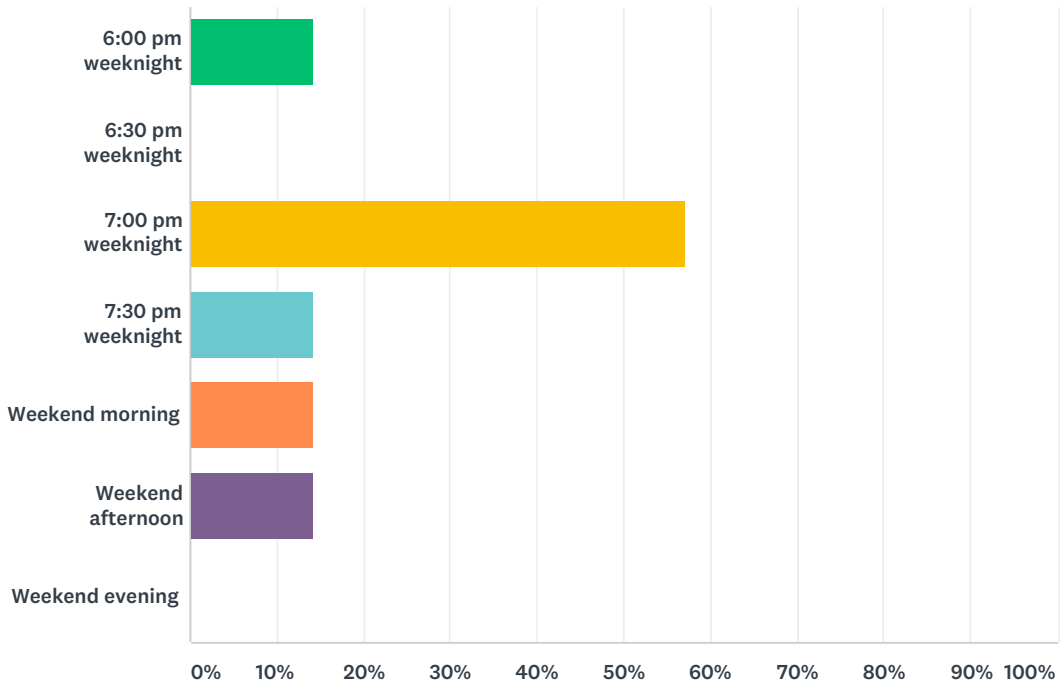

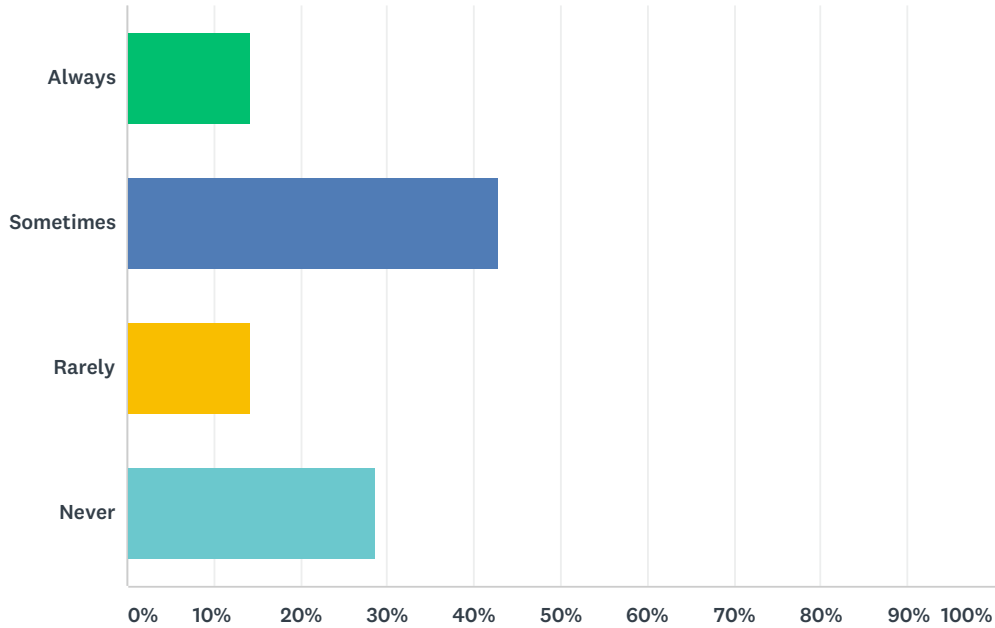

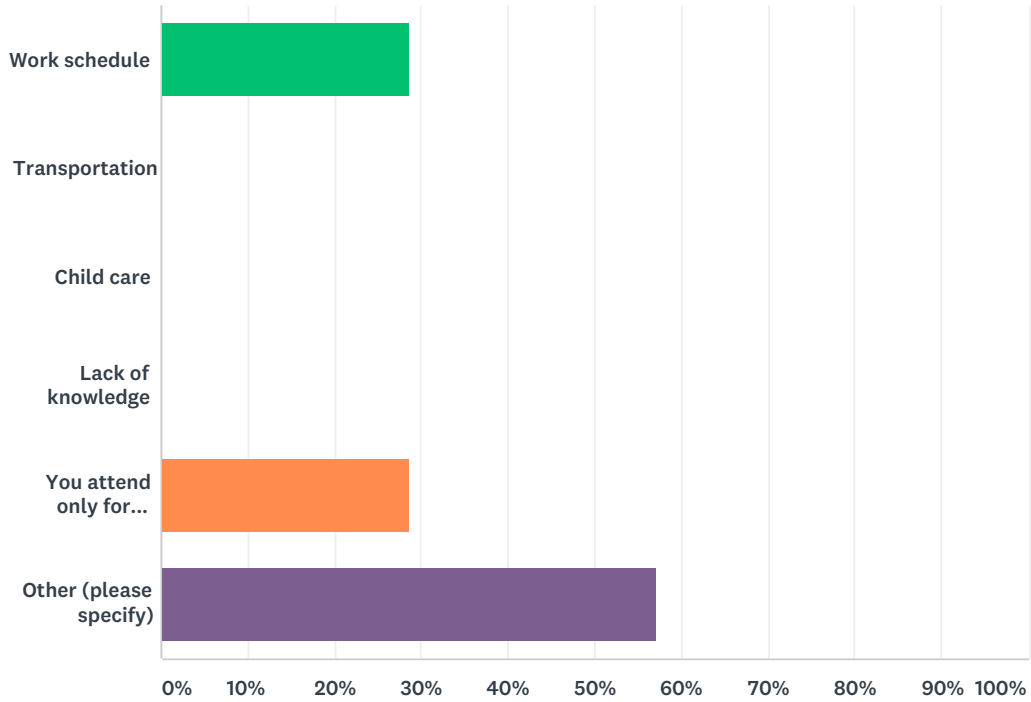

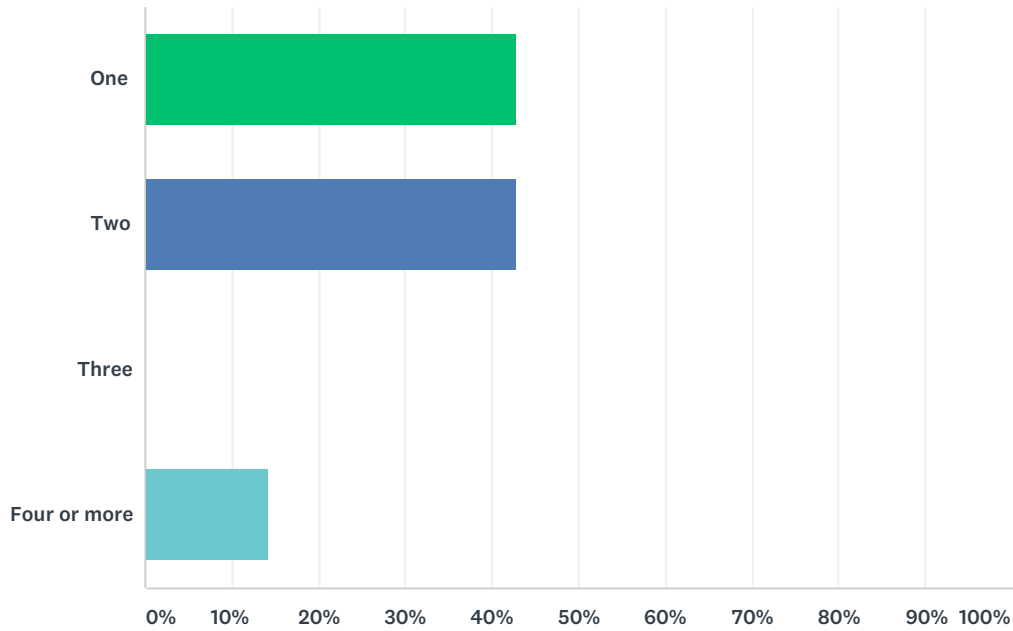

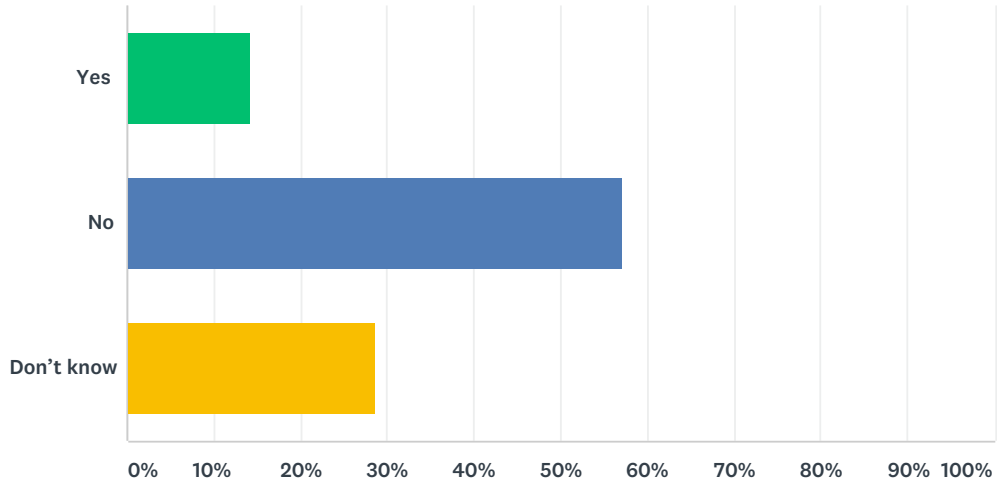

### Q27 Is a lottery system for the order of warrant articles a good idea?

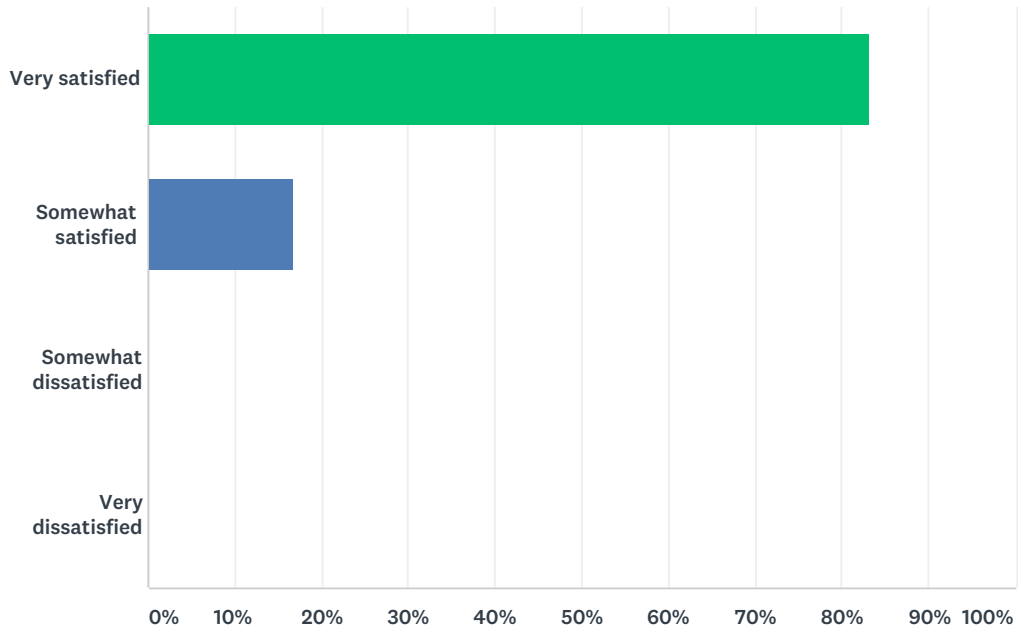

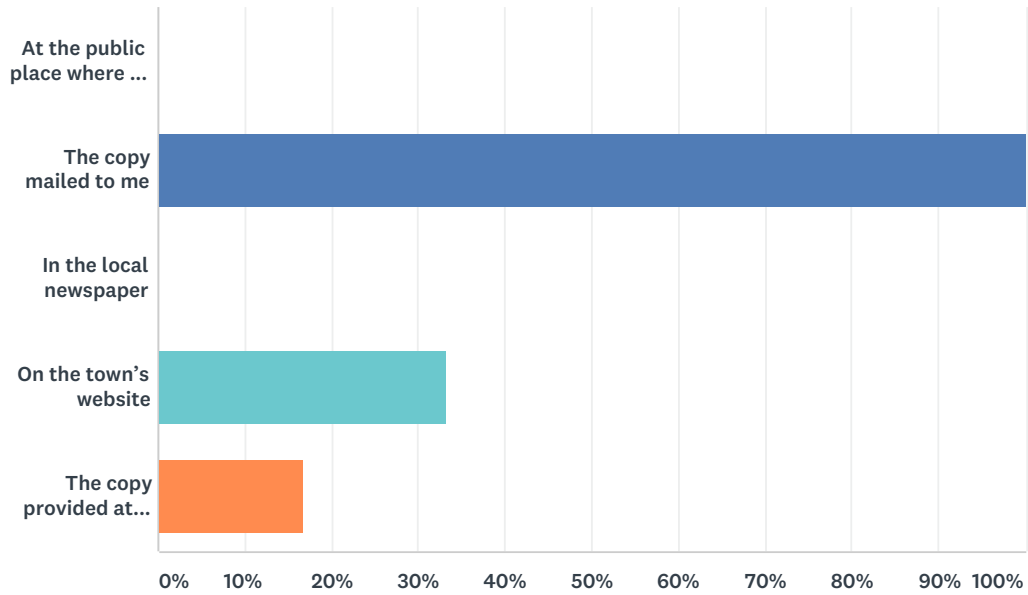

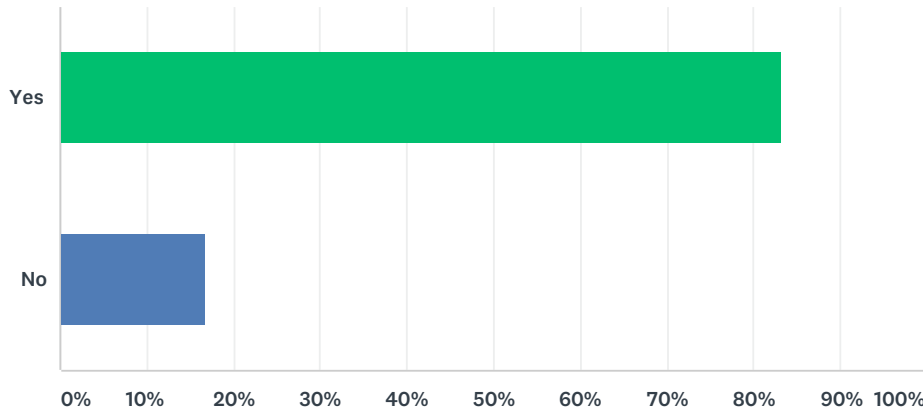

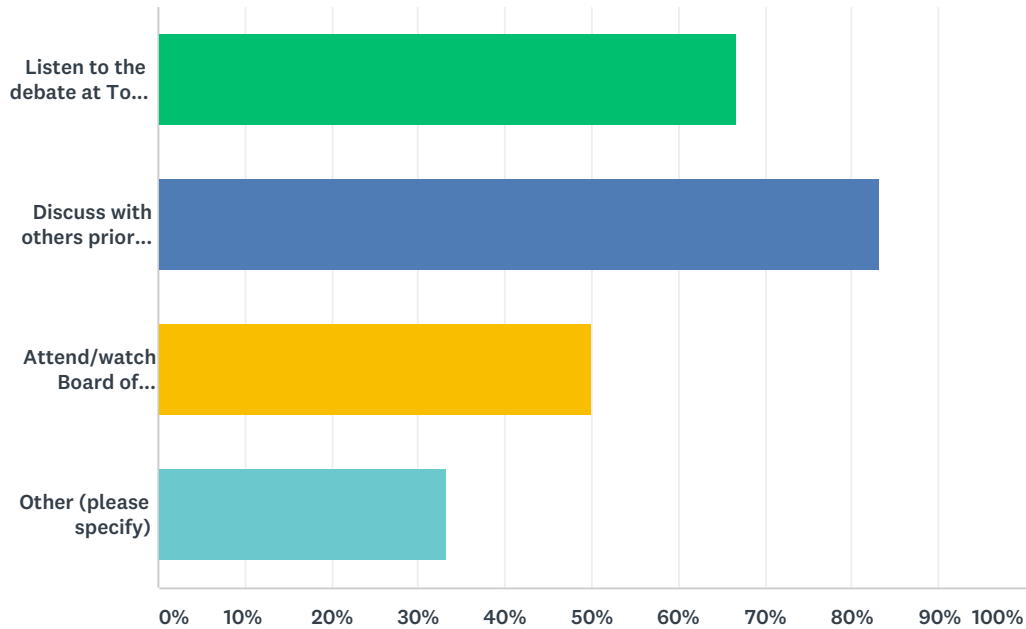

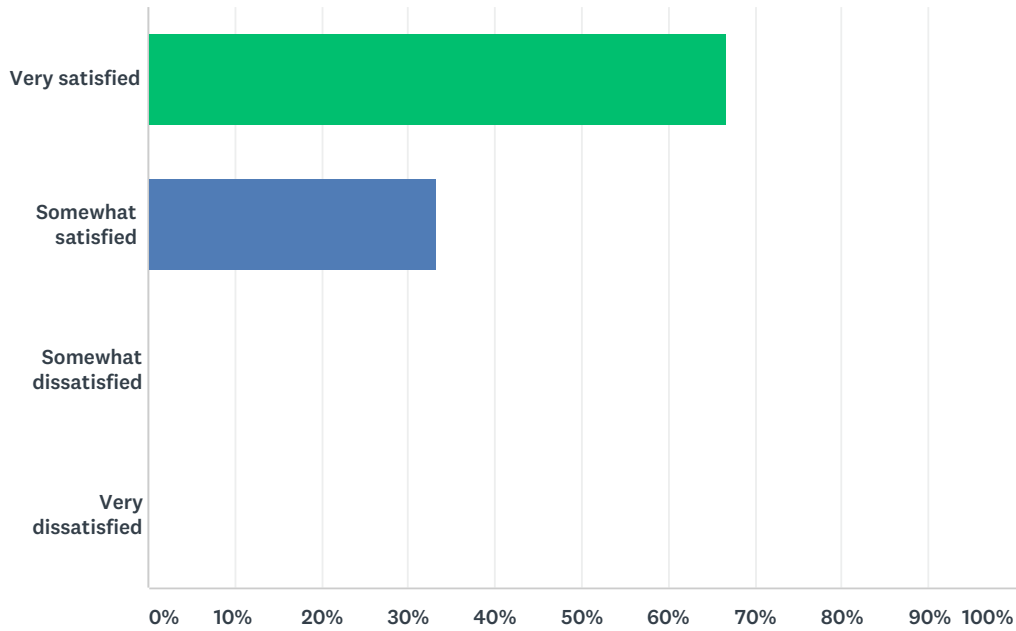

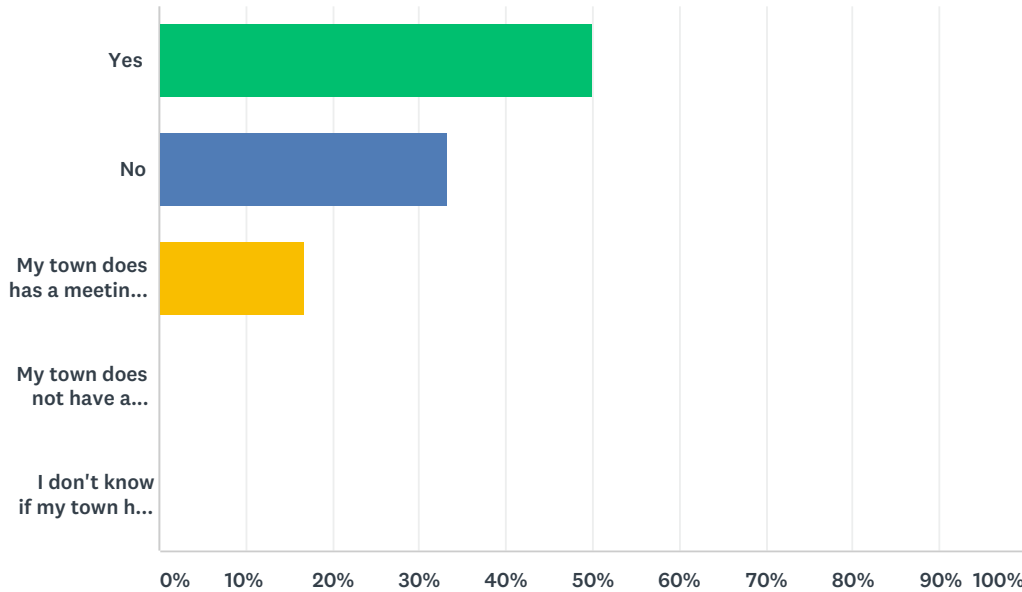

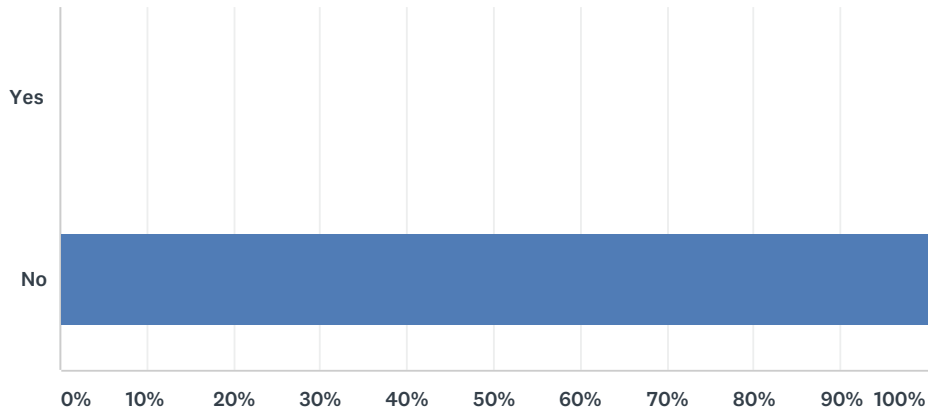

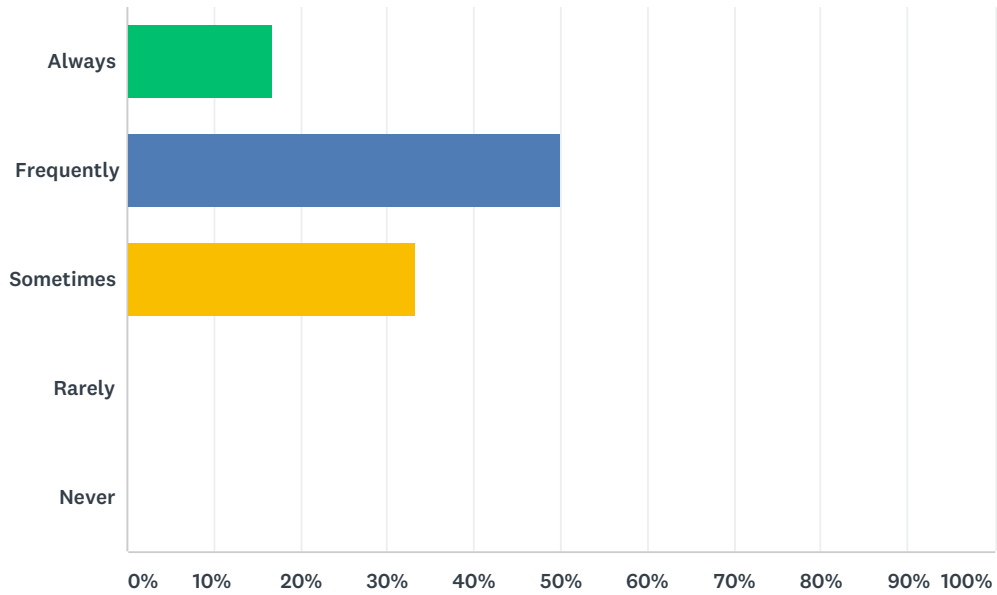

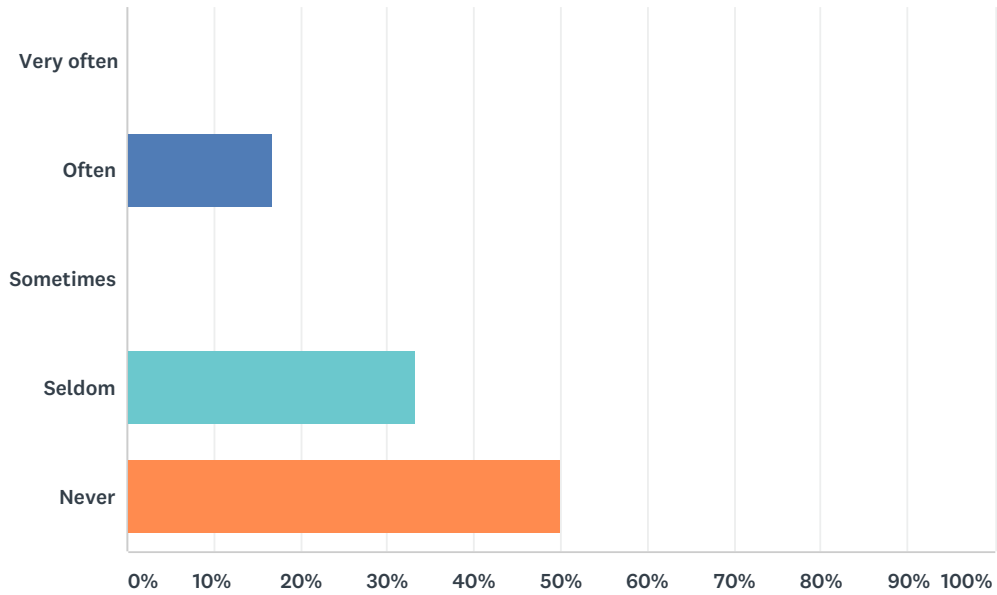

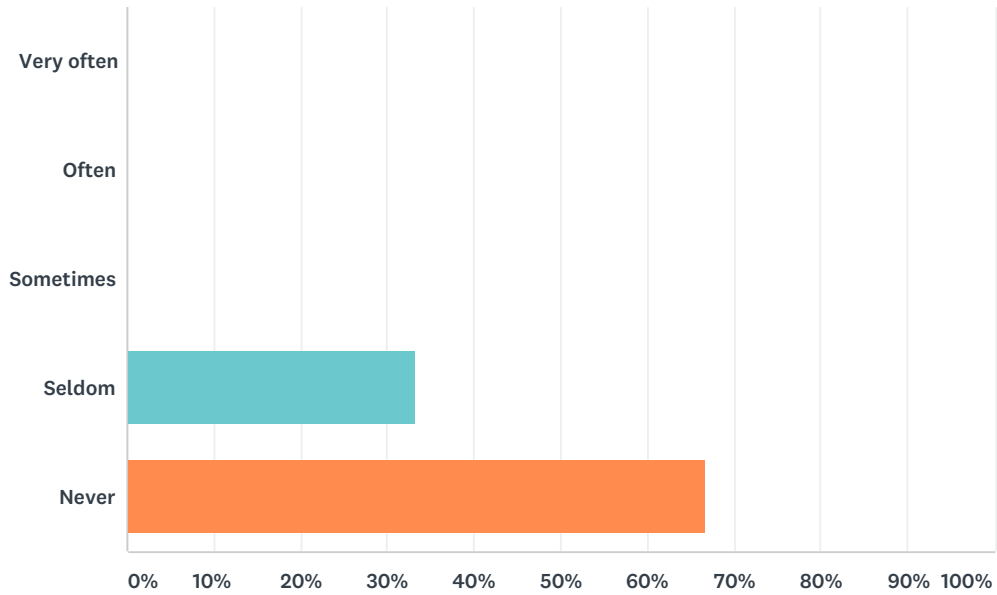

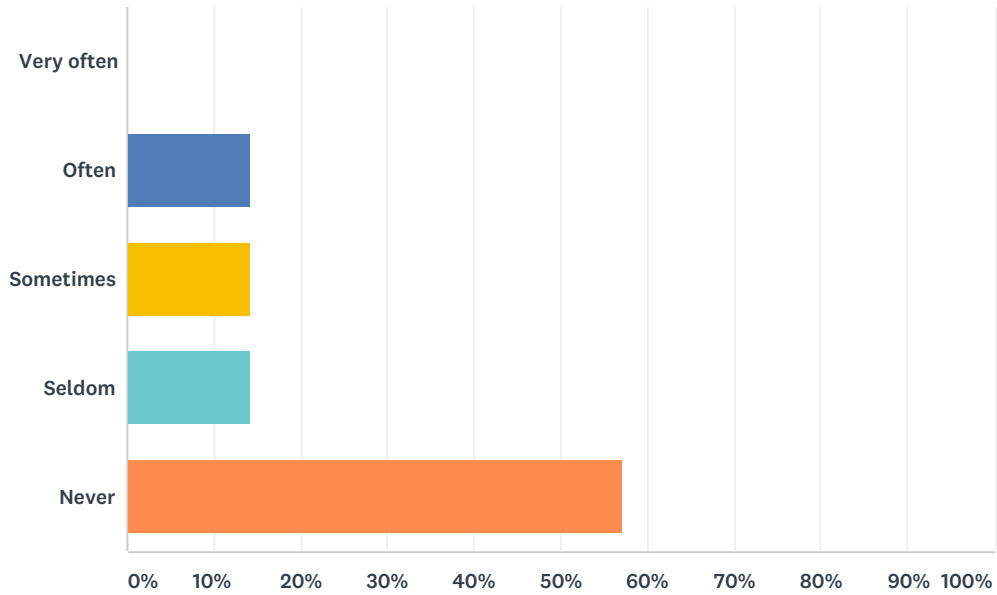

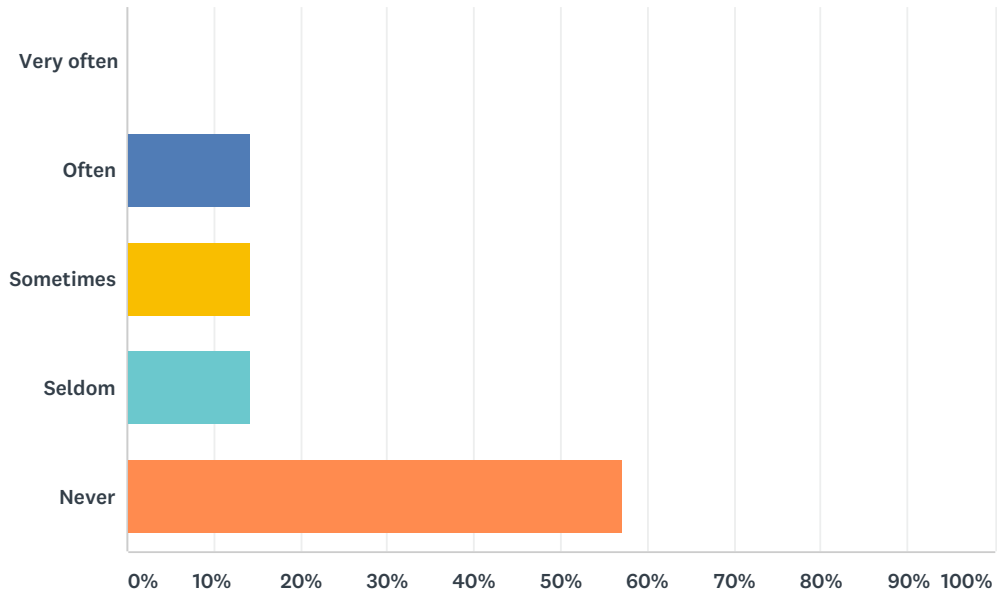

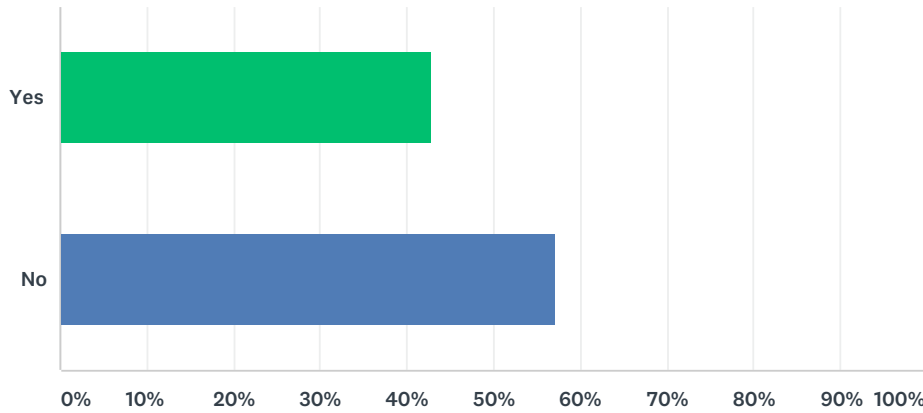

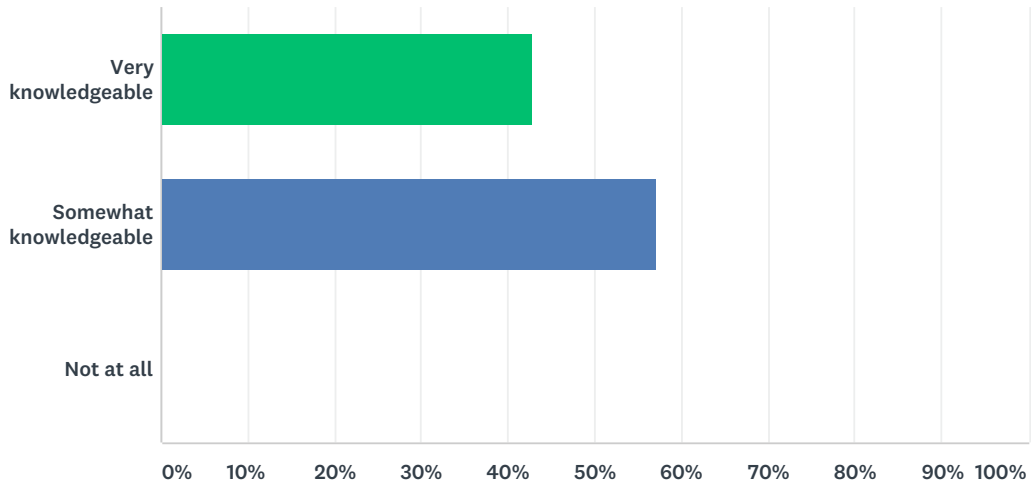

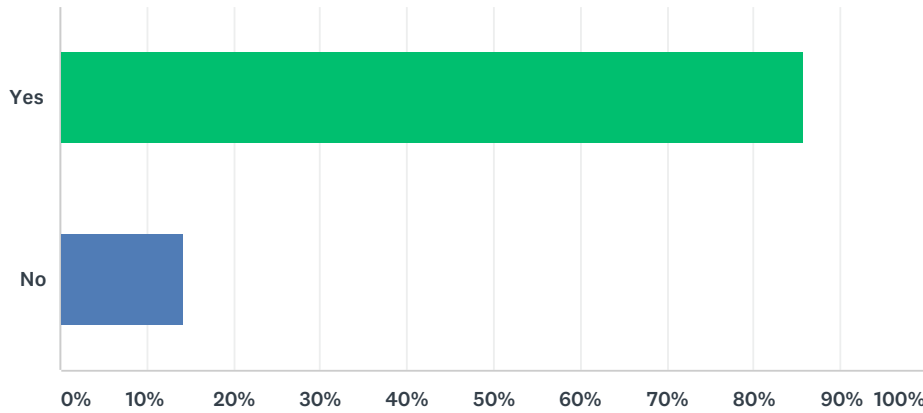

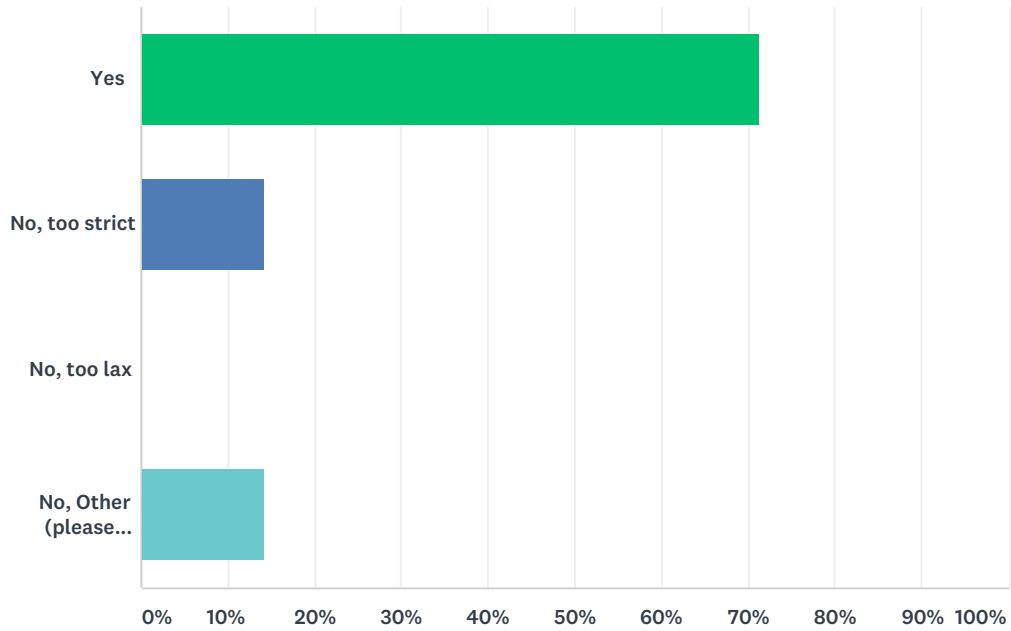

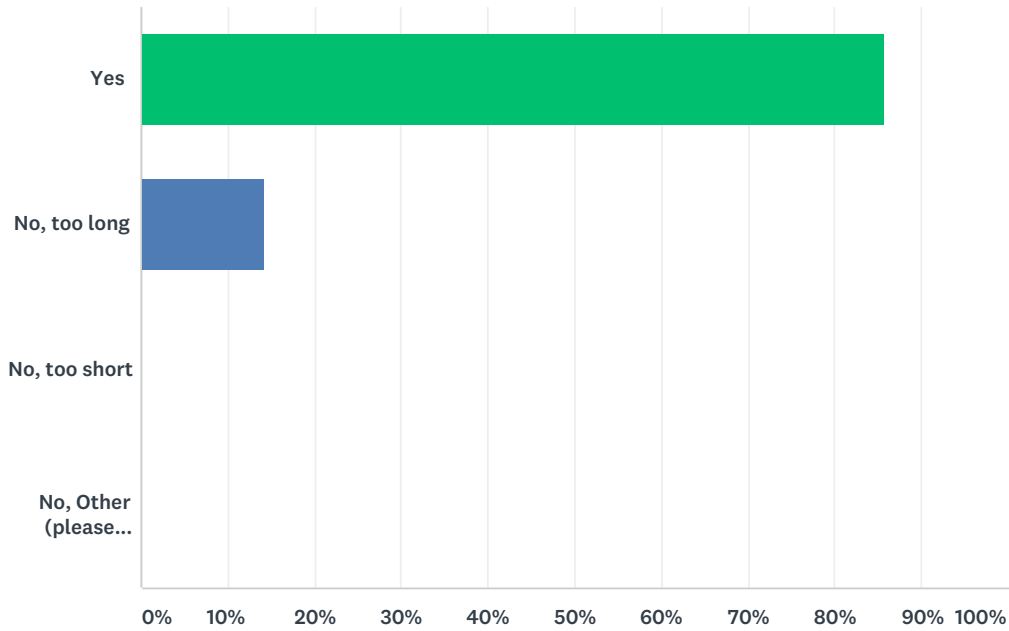

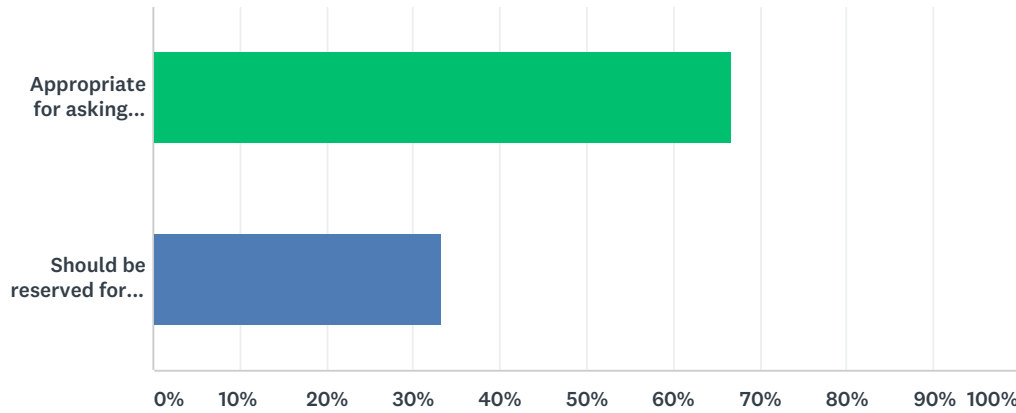

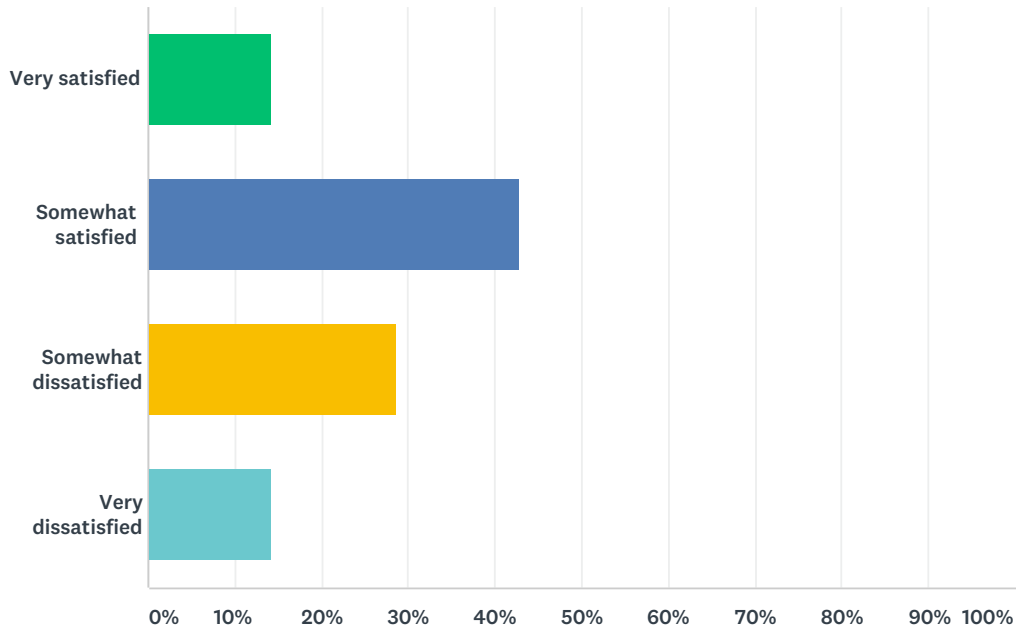

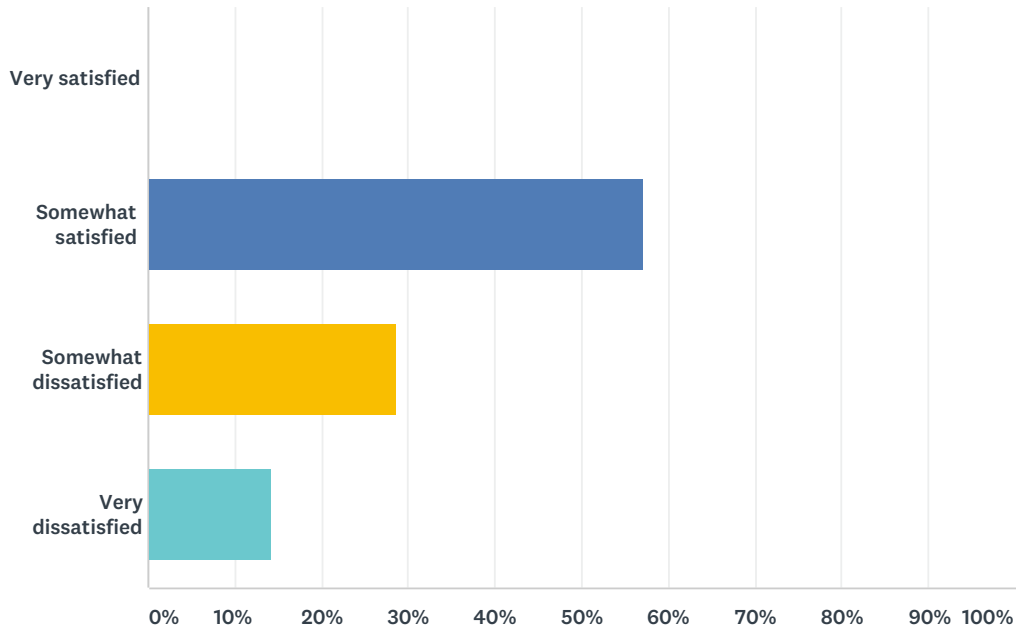

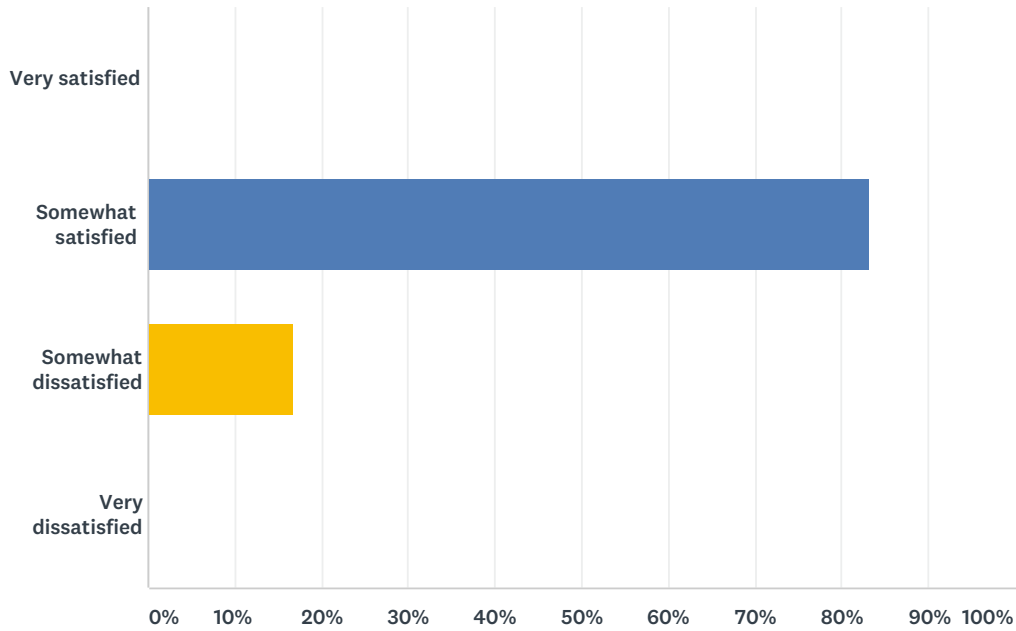

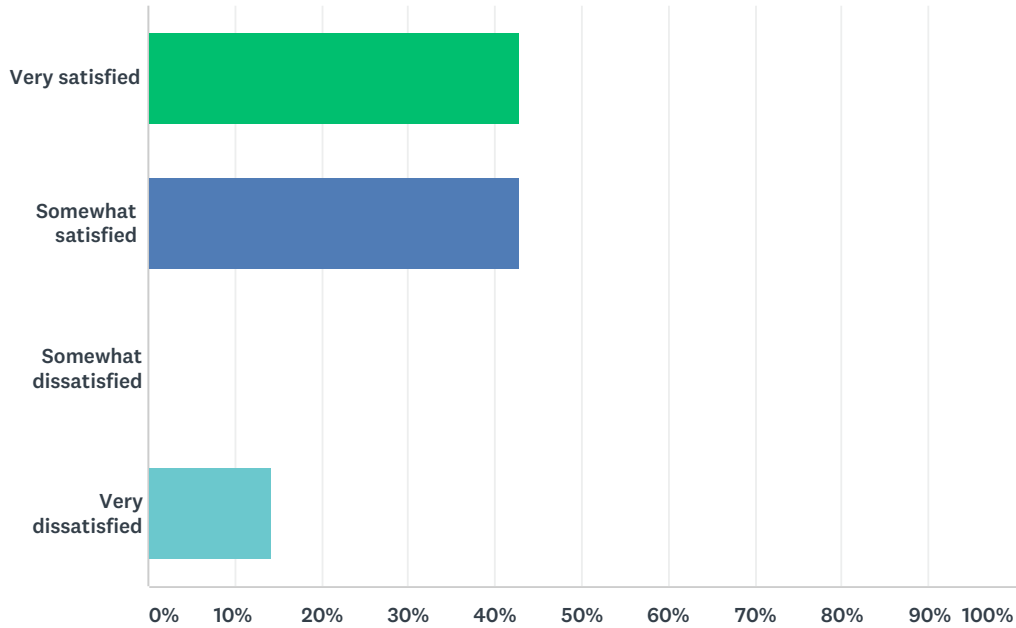

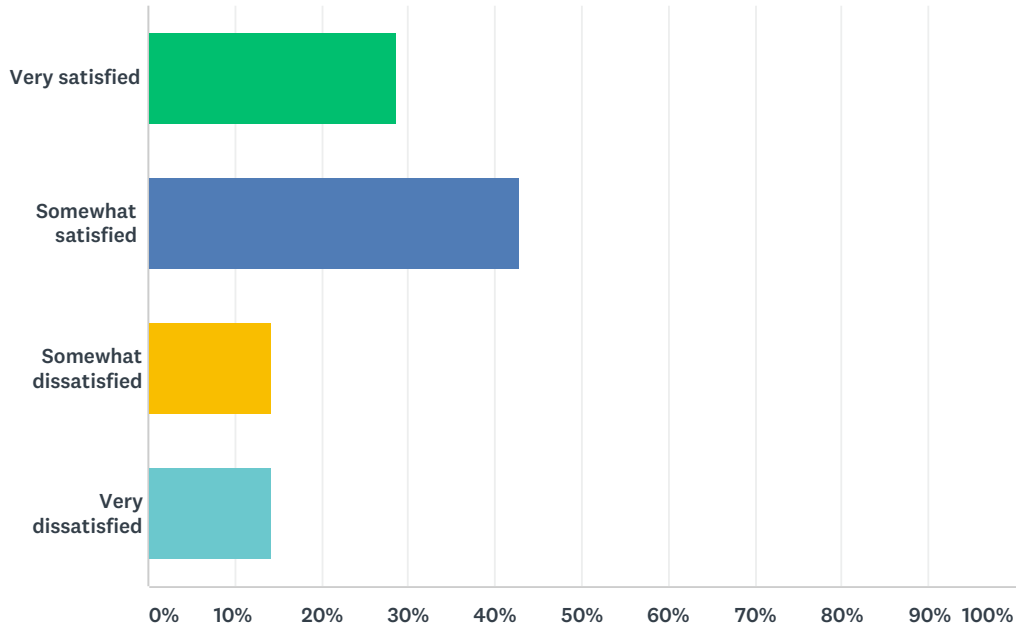

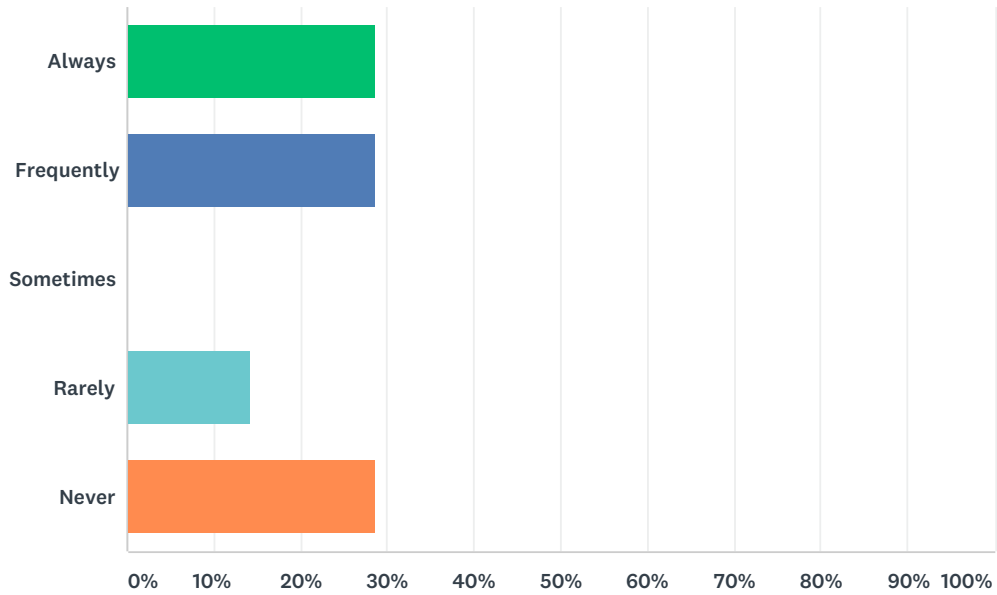

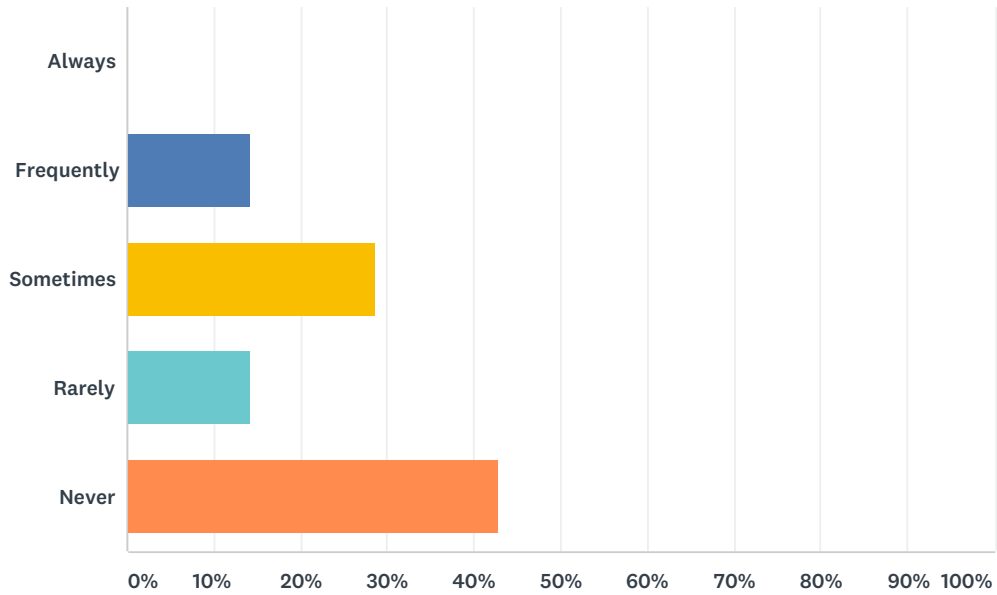

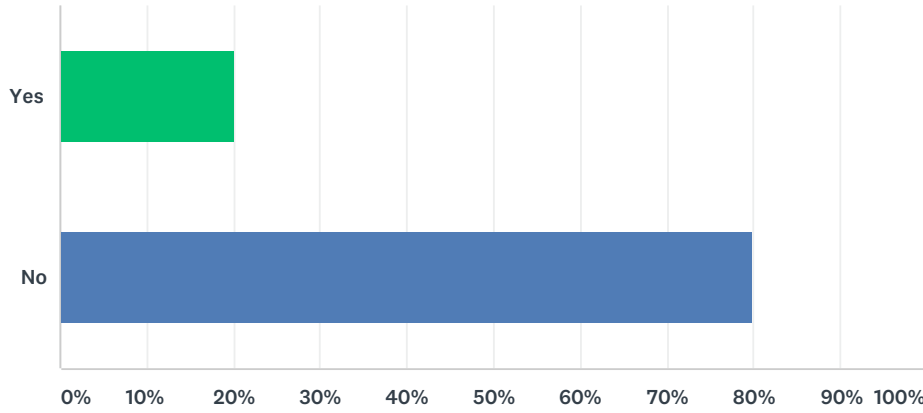

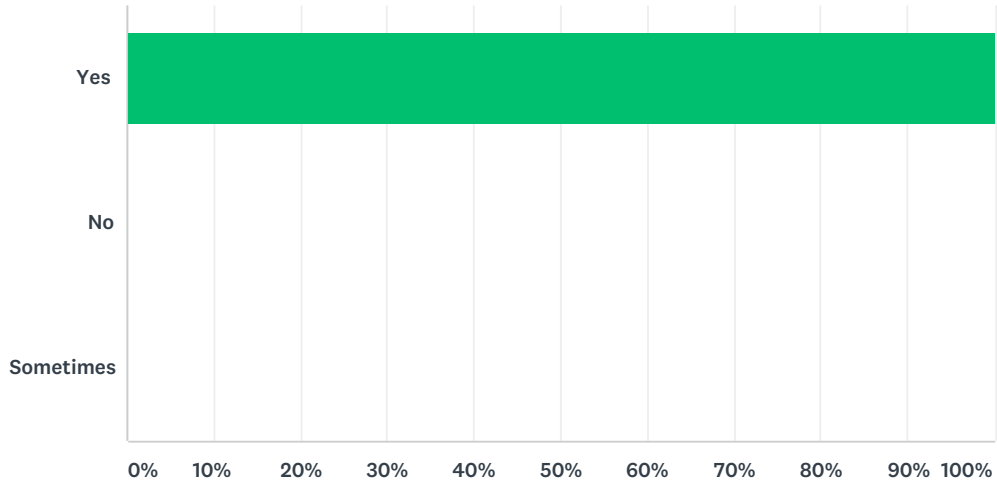

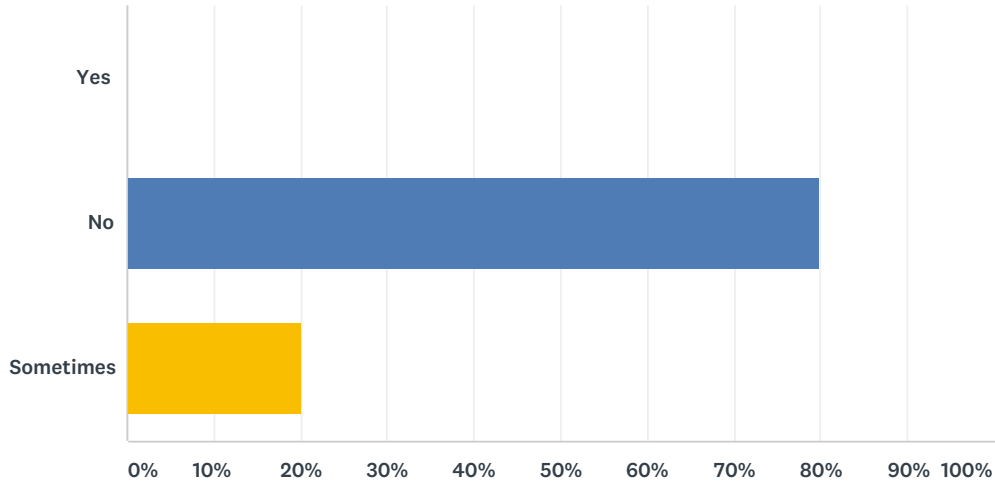

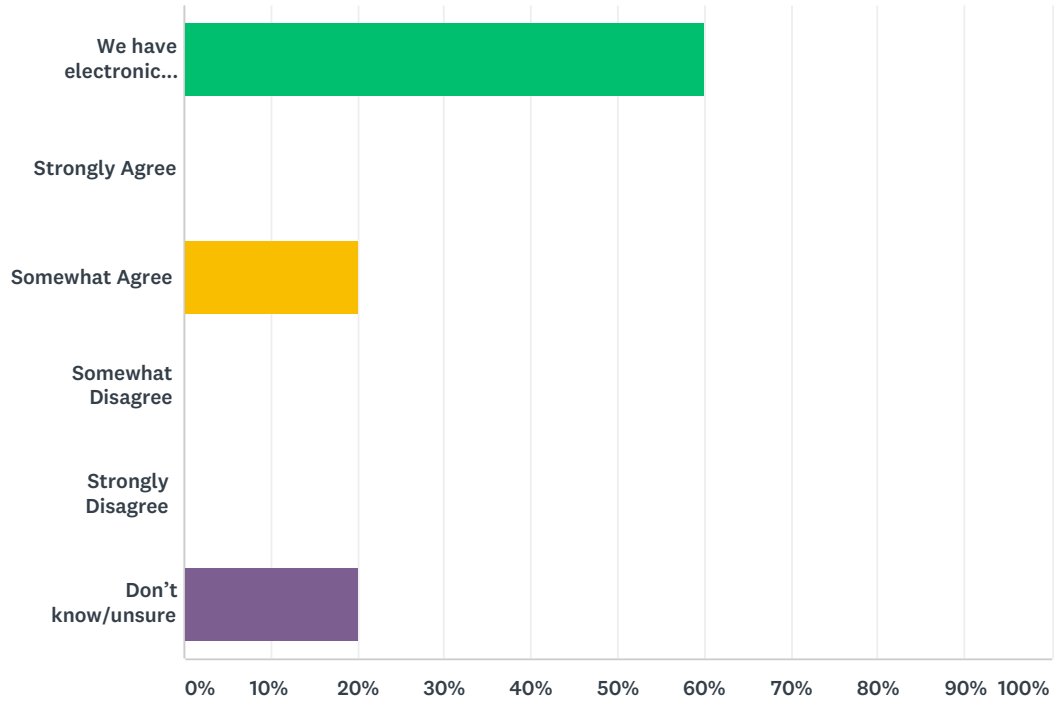

### Q66 Electronic voting should be investigated for use at Town Meeting:

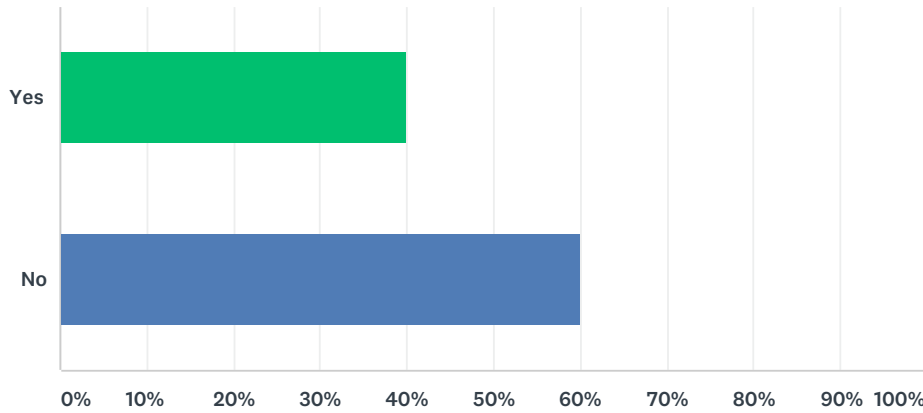

### Q67 Would you be more likely to vote if electronic voting were used at Town Meeting?

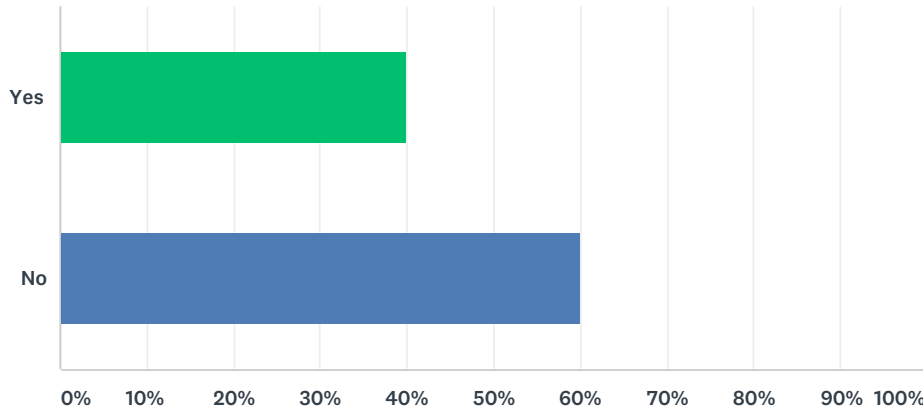

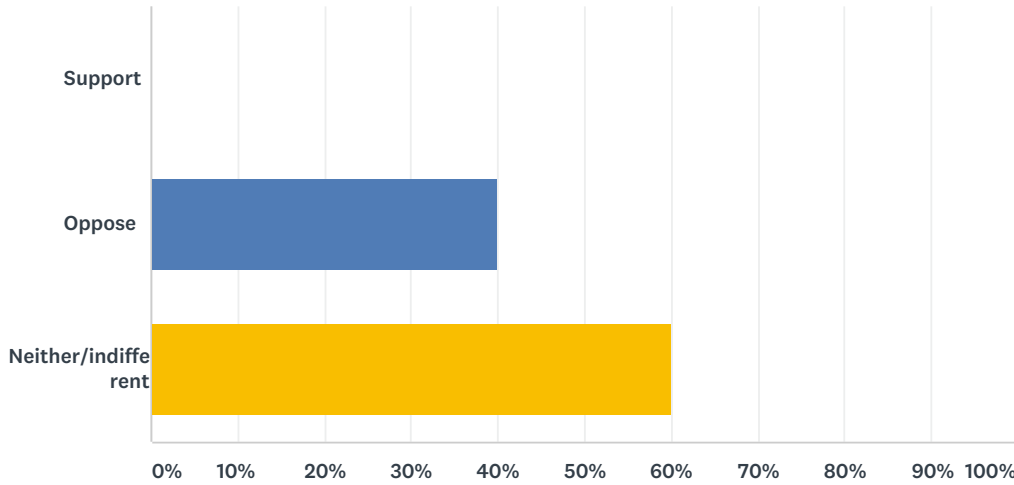

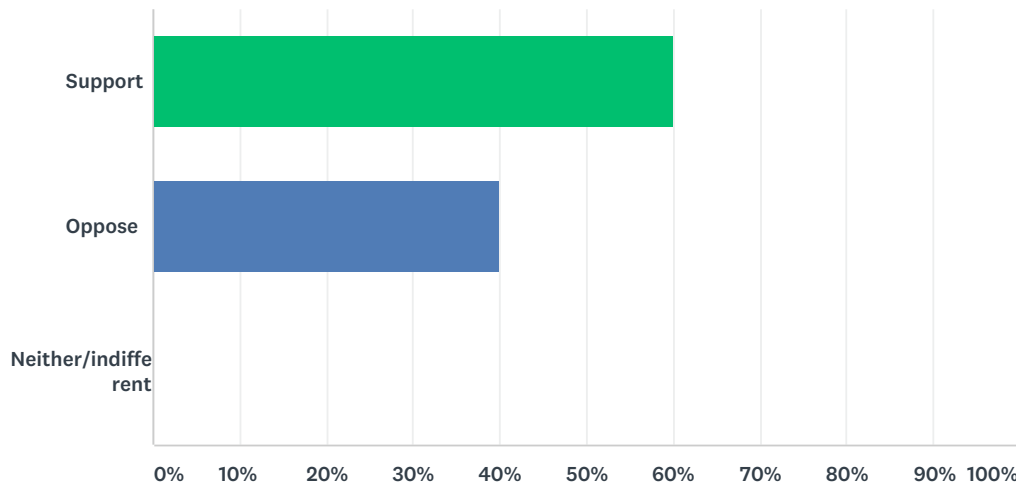

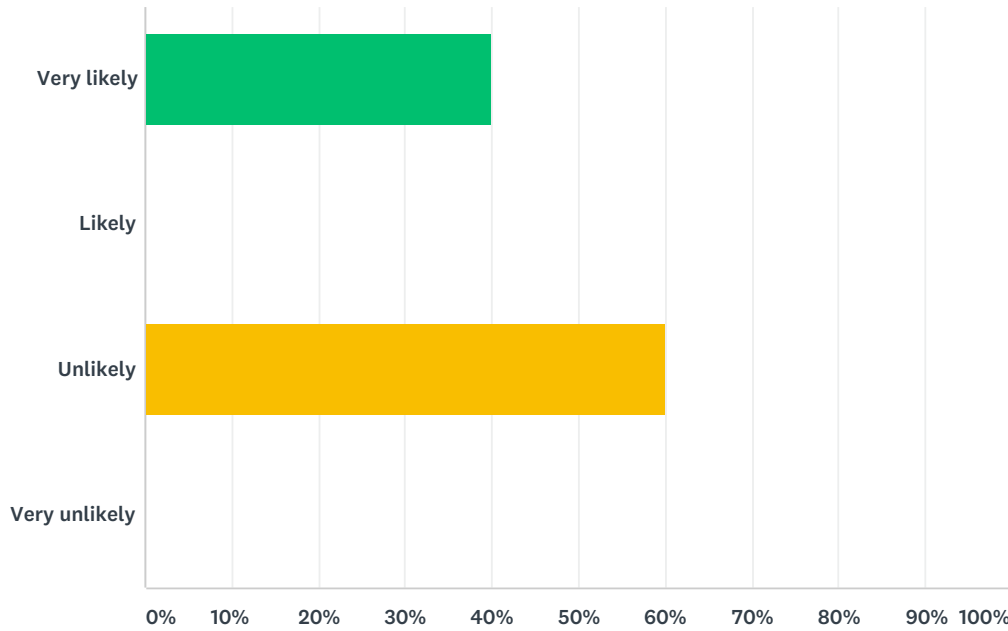

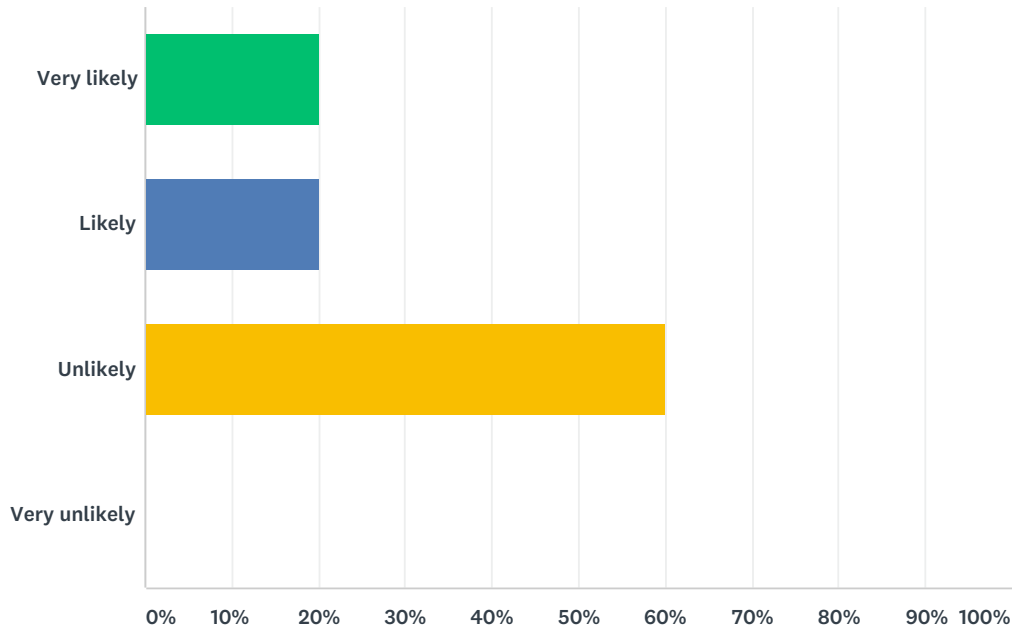

### Q72 If the above two-step process were adopted, how likely would you view the deliberative Town Meeting on TV or webcast?

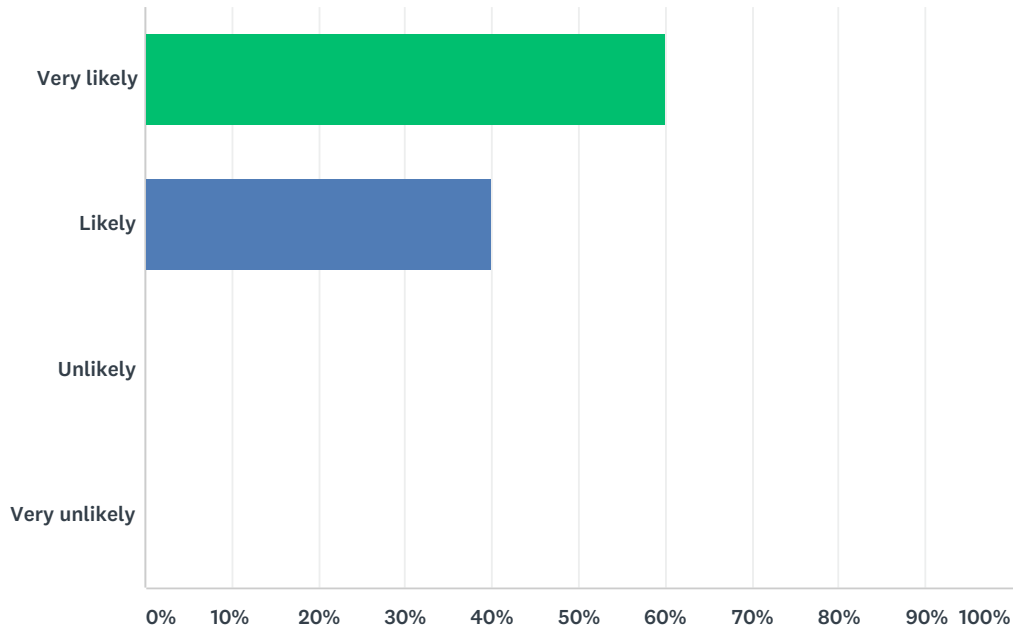
