Statewide Contract Q&A from the Webinar

Q: Would the rental contract cover large messaging signs?

A: Yes, the [FAC112](#) Equipment Rental contract covers large messaging signs. Buyers interested in purchasing these items are referred to the [HLS06](#) Homeland Security contract.

Q: Do State contract vendors offer site furnishings and are they immediately available?

A: [FAC104](#) vendors offer site furnishings, but inventory availability across our 30 vendors varies widely and changes quickly. We recommend that you reach out to Statewide Contract Vendors as soon as your needs are determined to request quotes and submit your purchase order. The Shared Streets & Spaces grant program may increase demand for these items and fulfillment will be accommodated on a first come, first serve basis.

Q: Are modular parklets available on contract with OSD? These are pre-made parklets the size of a parking space that are flush with the curb and easy to set up.

A: Modular parklets are available through [HLS06](#) and parklet-type materials are offered under [FAC104](#).

Q: Does the landscaping contract include design?

A: Although the landscaping contract does not accommodate design, we would refer you to two other contracts for these services. The [PRF69](#) Engineering Services contract offers multiple categories for these services and [PRF61](#) contract has two related categories: Environmental and Revitalization Consulting Services.

Q: Do any of the contracts cover MUTCD signs or similar? We have a sign shop but can't necessarily make all the signage we might need, some of it which may be custom-made.

A: Yes, these regulatory traffic signs are available through our [HLS06](#) Homeland Security contract.

Q: Are portable ramps for accessibility something that is provided on contract?

A: The [HLS06](#) Homeland Security contract also covers portable accessibility ramps.

Q: Do you offer any labor/material combined contracts for pavement marking contractors?

A: Yes, we have paving contractors through the [TRD02](#) trades contract. Services encompass asphalt paving, as well as the marking of parking lots and streets to include distance spacing along sides of roads. Although the contract has no threshold for materials purchasing, labor is capped at \$50,000.

Q: Are there misters and other cooling devices available under Statewide Contract?

A: Air misters/air handling equipment are available for rental under [FAC112](#). Additionally, they may be purchased under [FAC100](#), Category 4: HVAC and Refrigeration Products and Supplies; and [FAC101](#) through the Heating, Ventilation, Air Conditioning/Refrigeration (HVAC) category as a commodity-only purchase. Air handling equipment purchasing, installation, and services may be acquired through the [TRD01](#) Tradesperson contract through the HVAC/Sheet Metal Services category.
