



Conference Committees

Conference Committees

- 3 members from each chamber (2 majority party, 1 minority party)
- Approval of at least 2 members of each chamber required for a valid report
- Their reports MAY NOT be amended



Major Bills in Conference Committee

Economic Development Bond Bill

Transportation Bond Bill

Police Reform Legislation

Climate Legislation

Health Care Legislation



FY21 Budget: Not in Conference Committee but still important

Like many bills, the budget has multiple sections

- SECTION 2 has line items with language indicating how they're spent
- The other sections are generally referred to as "outside sections".
 - Originally designed to be a "controlling measure" that is associated with a line-item, these now contain policies that may not connected to the budget at all.

Amendments

- Each branch will typically file +1,000 amendments during their debates
- HWM and SWM rely on legislators' input to prioritize spending

In a usual year:

- HWM debates end of April
- SWM debates end of May

This year:

- Budget debate has not yet occurred
- Partial budget to fund through 10/31
- Consensus revenue hearing in October



District Local Technical Assistance

Requesting \$3 million

- DLTA funding helps cities and towns throughout the state expand what they can do, enabling them to take on projects they don't have the capacity to complete on their own.
- At least half of Massachusetts communities don't have professional planners to help shape their future economic development, transportation, housing, green spaces, and town facilities.
- Small but impactful increase to funding source available statewide.



Not quite done yet: Governor's Actions

Governor has 10 days to act

Sign the bill, making it law

Amendment

 Returns the bill to chamber that gave the bill its 1st reading

Veto

 Returns the bill to chamber that gave the bill its 1st reading

No action

Bill becomes law
