

2023 CLEAN SCHOOL BUS REBATE PROGRAM

Application Deadline: January 31, 2024 at 4:00 p.m.

The U.S. Environmental Protection Agency (EPA) has announced the second rebate funding opportunity through its multi-year <u>Clean School Bus Program</u>. The EPA will award up to \$500 million in rebate funding under the 2023 program. The funding is available for the purchase of up to 25 electric school buses per school district, as well as associated charging infrastructure and eligible workforce development costs.


MASSACHUSETTS DREDGING PROGRAM

FY25 Inland Dredging Pilot Round now open.

The Massachusetts Executive Office of Economic Development (EOED) announced the opening of the FY25 Inland Dredging Pilot Round of the Massachusetts Dredging Program. This round offers final design and construction grants to Massachusetts municipalities to support dredging of freshwater lakes, ponds, rivers, streams, and drinking water reservoirs, as well as dredging required for the removal of municipal dams. ROUND 30 OF THE MASSACHUSETTS PRESERVATION PROJECTS FUND

MHC announced Round 30 of the Massachusetts Preservation Projects Fund (MPPF) grant program. It is anticipated that funding for Round 30 will be in the range of \$1,000,000.

The MPPF is a state-funded 50% reimbursable matching grant program established in 1984 to support the preservation of properties, landscapes, and sites (cultural resources) listed in the State Register of Historic Places. Applicants must be a municipality or nonprofit organization.

Historic cultural resources in public and nonprofit ownership and use frequently suffer from deferred maintenance, incompatible use, or are threatened by demolition. By helping historic cultural resources owned by nonprofit or municipal entities, we hope to ensure their continued use and integrity.
