
Environmental Planning at MAPC, Van Du

Engagement Opp: Take the Flooding Survey (EEA, DCR, RPAs)

- In collaboration with regional planning agencies, the Executive Office of Energy and Environmental Affairs (EEA) and the Department of Conservation and Recreation (DCR) are conducting a Massachusetts Flood Vulnerability Assessment to identify where and how flooding is occurring in EJ communities.
- As part of this effort, the project team is administering a survey and hoping to hear from municipal and community leaders from across the state, especially representatives from EJ communities. Your participation is crucial to ensuring that the voices of those most impacted by flooding are heard, and that effective, equitable solutions are developed.
