MassDEP has a funding opportunity for private, public, and non-profit entities to replace eligible diesel vehicles and equipment with zero emission technologies.

Through the federal Diesel Emissions Reduction Act (DERA) program, Massachusetts is conducting a competitive electric-only Solicitation with an application deadline of 5 PM, April 7, 2025. See the <u>website for</u> <u>more information</u>. Eligible diesel vehicles, engines and equipment include, but are not limited to, the following diesel emission source types:

- School Buses
- Transit Buses
- Medium-duty or heavy-duty trucks
- Marine Engines
- Locomotives
- Nonroad engines, equipment, or vehicles

The eligible technologies that can be applied to the above vehicles, engines and equipment include:

- Vehicle and equipment replacements with Zero-tailpipe Emission Power Source
- Engine replacements with Zero-tailpipe Emission Power Source
- Verified idle reduction technologies

MHC Announcing Massachusetts Preservation Projects Fund (MPPF) grant program

- Secretary William F. Galvin, Chair of the Massachusetts Historical Commission is pleased to announce that Round 31 of the Massachusetts Preservation Projects Fund (MPPF) grant program has been scheduled. It is anticipated that funding will be in the range of \$1,000,000.
- Administered by the Massachusetts Historical Commission (MHC), the MPPF is a state-funded 50% matching grant reimbursement program established in 1984 to support the preservation of properties, landscapes, and sites listed in the State Register of Historic Places. Applicants must be a municipality or nonprofit organization. The program is administered in accordance with 950 CMR 73.00.

ADUs Legislation Effective as of February 2, 2025 - Final Regulations Released

- Accessory Dwelling Units (ADUs) legislation is now in full effect as of February 2, 2025.
- The Massachusetts Executive Office of Housing and Livable Communities (EOHLC) released <u>final</u> recommendations, which include clarity on the administration of the new law.
